<u>COUNT ONE</u> [18 U.S.C. §§ 922(a)(6), 924(a)(2), & 2]

On or about July 9, 2010, in the Western District of Texas, the Defendant,

ISRAEL CANTU

in connection with the acquisition of a firearm, a Romanian WASR-10 7.62 x 39 rifle, serial number 1988-ACT 3528, from Day Arms Corporation, a federally licensed firearms dealer, did knowingly aid and abet the making of a false and fictitious oral or written statement, which statement was intended and likely to deceive the dealer as to a fact material to the lawfulness of such sale of the said firearm, in that the Defendant aided and abetted Maria Montelongo Zavala, who represented that she was the actual buyer of the firearm, when in fact she was not the actual buyer of the firearm; in violation of Title 18, United States Code, Sections 922(a)(6), 924(a)(2), and 2.

COUNT TWO [18 U.S.C. §922(g)(1) & §924(a)(2)]

That on or about July 9, 2010, in the Western District of Texas, Defendant,

ISRAEL CANTU

having been convicted of a crime punishable by imprisonment for a term exceeding one year, to wit: the Defendant was convicted in the 290th District Court of Bexar County, Texas, of Unauthorized Use of a Vehicle, in Cause No. 2000-CR-4122w; and the Defendant was convicted in the 144th District Court of Bexar County, Texas, of Theft of Property Greater than \$20,000, in Cause No. 2003-CR-9546; did knowingly possess in and affecting commerce a firearm, a Romanian WASR-10 7.62 x 39 rifle, serial number 1988-ACT 3528, in violation of Title 18, United States Code, Sections 922(g)(1) and 924(a)(2).

<u>COUNT THREE</u> [18 U.S.C. §§ 922(a)(6) & 924(a)(2)]

On or about July 9, 2010, in the Western District of Texas, the Defendant,

MARIA MONTELONGO ZAVALA

in connection with the acquisition of a firearm, a Romanian WASR-10 7.62 x 39 rifle, serial number 1988-ACT 3528, from Day Arms Corporation, a federally licensed firearms dealer, knowingly made a false and fictitious oral or written statement, which statement was intended and likely to deceive the dealer as to a fact material to the lawfulness of such sale of the said firearm to the Defendant, in that the Defendant represented that she was the actual buyer of the firearm, when in fact she was not the actual buyer of the firearm; in violation of Title 18, United States Code, Sections 922(a)(6) and 924(a)(2).

<u>COUNT FOUR</u> [18 U.S.C. §§ 922(a)(6), 924(a)(2), & 2]

On or about July 17, 2010, in the Western District of Texas, the Defendant,

JOSE YTUARTE

in connection with the acquisition of a firearm, a Romanian WASR-10 7.62 x 39 rifle, serial number

1972 CC 0989, from Day Arms Corporation, a federally licensed firearms dealer, did knowingly aid and abet the making of a false and fictitious oral or written statement, which statement was intended and likely to deceive the dealer as to a fact material to the lawfulness of such sale of the said firearm, in that the Defendant aided and abetted Amanda Torres Ytuarte, who represented that she was the actual buyer of the firearm, when in fact she was not the actual buyer of the firearm; in violation of Title 18, United States Code, Sections 922(a)(6), 924(a)(2), and 2.

<u>COUNT FIVE</u> [18 U.S.C. §922(g)(1) & §924(a)(2)]

That on or about March 10, 2011, in the Western District of Texas, Defendant,

JOSE YTUARTE
