INDICTMENT

THE GRAND JURY CHARGES:

YAHIR RICARDO GARCIA-MATIAS also known as "Paraja,"

Count One

On or about July 13, 2010, in the Southern District of Texas and within the jurisdiction of the Court, defendant,

JOSE DURAN-LOERA also known as "Nitas"

previously having been convicted in the 332nd District Court of Hidalgo County, Texas, on March 22, 2010, for the felony offense of Burglary of Habitation, in Cause number CR-865-10-F, a crime punishable by imprisonment for a term exceeding one year, did knowingly and unlawfully possess in and affecting interstate and foreign commerce a firearm, namely a Century International Arms, Model WASR 10/63, 7.62mm rifle, serial number 1969BP0188.

In violation of Title 18, United States Code, Sections 922(g)(1) and 924(a)(2).

Count Two

knowingly made, a false statement and representation with respect to information required to be kept in the records of Southwest Hay & Feed, Co., Pharr, Texas, a federally licensed firearms dealer, in connection with the acquisition of a Century International Arms, Model WASR 10, 7.62mm rifle, serial number 1983AH2313; and a Century International Arms, Model WASR 10, 7.62mm rifle, serial number 1984PF6383, in that the defendant JOSE DURAN-LOERA also known as "Nitas", falsely represented on the Bureau of Alcohol, Tobacco, and Firearms Form 4473, that defendant JOSE DURAN-LOERA also known as "Nitas", was the actual buyer of the firearms described above, when in truth and fact the defendant knew that those statements and representations were false and that JOSE DURAN-LOERA also known as "Nitas", was not the actual buyer of the firearms.

- 10. On or about July 1, 2010, defendant HUMBERTO GALVAN, also known as "Flaco", falsely represented on the Bureau of Alcohol, Tobacco, and Firearms Form 4473, that defendant HUMBERTO GALVAN, also known as "Flaco", was the actual buyer of a

 Century International Arms, Model SP WASR 10, 7.62mm rifle, serial number 1986RE7684; and a Century International Arms, Model SP WASR 10, 7.62mm rifle, serial number 1967AD1455, from Southwest Hay and Feed, Mission, Texas, a federally licensed firearms dealer, when in truth and fact defendants HUMBERTO GALVAN, also known as "Flaco," JOSE DURAN-LOERA, also known "Nitas" and YAHIR RICARDO GARCIA-MATIAS, also known as "Paraja," knew that those statements and representations were false and that HUMBERTO GALVAN, also known as "Flaco", was not the actual buyer of the firearm.
- 11. On or about July 1, 2010, prior to making a firearm purchase from Southwest Hay and Feed, defendant HUMBERTO GALVAN, also known as "Flaco," traveled with defendant JOSE DURAN-LOERA, also known "Nitas," to a parking lot in Hidalgo County, Texas and met with defendant, YAHIR RICARDO GARCIA-MATIAS also known as "Paraja," at which time defendant YAHIR RICARDO GARCIA-MATIAS, also known as "Paraja," provided defendant JOSE DURAN-LOERA, also known "Nitas," with money to firearms.
- 12. On or about July 1, 2010, prior to making a firearm purchase from Southwest Hay and Feed, defendant JOSE DURAN-LOERA, also known "Nitas," while in Hidalgo County, Texas and met with defendant YAHIR RICARDO GARCIA-MATIAS, also known as "Paraja," at which time defendant YAHIR RICARDO GARCIA-MATIAS, also known as "Paraja," directed defendant JOSE DURAN-LOERA, also known "Nitas," as to which firearms to purchase and the quantity thereof.
