DR11CR0094

COUNT ONE

[18 U.S.C. §§ 922(a)(6) & 924(a)(2)]

On or about June 23, 2010, in the Western District of Texas, the Defendant,

RONALD JOSEPH EDWARDS

in connection with the acquisition of a firearm, a Bushmaster M4 .223 rifle, serial number L518393, from Don's Gun Shop, a federally licensed firearms dealer, knowingly made a false and fictitious oral or written statement, which statement was intended and likely to deceive the dealer as to a fact material to the lawfulness of such sale of the said firearm to the Defendant, in that the Defendant represented that he was the actual buyer of the firearm, when in fact he was not the actual buyer of the firearm; in violation of Title 18, United States Code, Sections 922(a)(6) and 924(a)(2).


On or about July 7, 2010, in the Western District of Texas, the Defendant,


