THE GRAND JURY CHARGES:

DRI 1 CR 0152

COUNT ONE

[18 U.S.C. §§ 922(a)(6) & 924(a)(2)]

On or about August 10, 2010, in the Western District of Texas, the Defendant,

ORALIA NARANJO ORTEGA

in connection with the acquisition of a firearm, a Century Arms AK-47 rifle, serial number 1977HF3148, from Don's Gun Shop, a federally licensed firearms dealer, knowingly made a false and fictitious oral or written statement, which statement was intended and likely to deceive the dealer as to a fact material to the lawfulness of such sale of the said firearm to the Defendant, in that the Defendant represented that she was the actual buyer of the firearm, when in fact she was not the actual buyer of the firearm; in violation of Title 18, United States Code, Sections 922(a)(6) and 924(a)(2).

COUNT TWO

[18 U.S.C. §§ 922(a)(6) & 924(a)(2)]

On or about August 10, 2010, in the Western District of Texas, the Defendant,

ORALIA NARANJO ORTEGA

in connection with the acquisition of a firearm, a Century WASR-10 AK-47 rifle, serial number 1988-ACM4690, from Nagle Gun Shop, Inc., a federally licensed firearms dealer, knowingly made a false and fictitious oral or written statement, which statement was intended and likely to deceive

the dealer as to a fact material to the lawfulness of such sale of the said firearm to the Defendant, in that the Defendant represented that he was the actual buyer of the firearm, when in fact he was not the actual buyer of the firearm; in violation of Title 18, United States Code, Sections 922(a)(6) and 924(a)(2).
