COUNT ONE

[18 U.S.C. § 554(a)]

On or about July 25, 2010, in the Western District of Texas, the Defendants,

did knowingly and unlawfully export or attempt to export from the United States, any merchandise, article, or object, to wit - approximately 20,900 rounds of ammunition, which included approximately 8,350 rounds of 9 millimeter ammunition and 12,550 rounds of .223 caliber ammunition, defense articles listed under Category III of the United States Munitions List, contrary to any law or regulation of the United States, in that the Defendants had not obtained a license or written authorization for such export, in violation of Title 22, United States Code, Section 2778(b)(2) and Title 22, Code of Federal Regulations, Parts 121, 123, & 127, all in violation of Title 18, United States Code, Section 554(a).
