## **INDICTMENT**

#### THE GRAND JURY CHARGES:

On or about June 3, 2017, in the Southern District of Texas and within the jurisdiction of the Court, defendant,

### ERIKA VERENIZ RODRIGUEZ

a felon, having been convicted of a crime punishable by imprisonment for a term exceeding one year, namely, in the 155<sup>th</sup> Judicial District Court, Fayette County, Texas on July 15, 2015, in case number 2015R-067(1), for Possession of Marihuana, in an amount more than 50 lbs and less than 2,000 lbs in violation of Texas Health & Safety Code Section 481.121(b)(5), did knowingly and unlawfully possess in and affecting interstate and foreign commerce a firearm, namely, seven (7) AK-47 style 7.62x39mm rifles, one (1) AK-47 style 7.62x39mm pistol, and one (1) Barrett Model 82A1 .50 caliber rifle.

In violation of Title 18, United States Code, Sections 922(g)(1) and 924(a)(2).
