Witness #1 stated that he eventually arrived to Las Palomas, Chihuahua, Mexico and made contact with an alien smuggler that eventually took him across the United States Border illegally. Witness #1 stated that the morning of November 6, 2017, he crossed into the United States along with 2 other subjects. Witness #1 stated that once they crossed the US/Mexico International Border, he walked to a vehicle and made contact with the passenger and driver. Witness #1 stated that he was told to get in the vehicle and was subsequently taken to a house in a nearby town. Once inside the house, the two subjects that transported them to the house took them food and water daily until the day he was arrested. Witness #1 added that the two subjects instructed them not to leave the house or they would be shot. Furthermore, Witness #1 stated that after the subjects dropped off food they could hear a chain like sound and he believed they were locked inside the house. Witness #1 stated that he never tried to leave the house for fear of getting shot. Witness #1 stated that both subjects knew he was illegally in the country because they both were demanding payment for the smuggling services. Witness #1 intended destination was Denver, Colorado and was going to be charged \$5,000 for the smuggling services. A photo lineup was provided to Witness #1 and he was able to identify the two subjects that picked him up after he crossed the US/Mexico International Border and subsequently took him to the house where he was kept until his arrest. Subjects were identified as Josias GARCIA and Eduardo CHAVEZ.

Witness #3 stated the Josias GARCIA showed him his driver's license and made contact with a family member of his and a total of \$5000 dollars were wired to a bank account provided by GARCIA.

## **CONCLUSION:**

- 1. Based on the aforementioned facts, your Affiant believes that there is probable cause to believe that Josias GARCIA and Eduardo CHAVEZ along with others known and unknown did violate Title 8 United States Code, Sections 1324 (a)(1)(A)(iii)(Harboring), 1324(a)(1)(A)(v)(I)(Conspiracy.
- 2. AUSA Luis Martinez was contacted by BPA Victor Garcia and advised of the above illegal alien smuggling scheme and prosecution was accepted on Josias GARCIA and Eduardo CHAVEZ for 8 USC 1324 (a)(1)(A)(iii)(Harboring), 1324(a)(1)(A)(v)(I)(Conspiracy.
