House Appropriations Committee July 12, 2007, Vote on Kennedy Amendment to Remove Tiahrt Restrictions on Crime Gun Tracing Data

The House Appropriations Committee rejected on a voice vote an amendment offered by Rep. Jim Moran to repeal the Tiahrt Amendment. The Committee then voted on an amendment offered by Rep. Patrick Kennedy to allow the release of crime gun trace data, which was also rejected. This vote is detailed below.
