THE GRAND JURY CHARGES:

DRI 1 CR0153

COUNT ONE

[18 U.S.C. §§ 922(a)(6) & 924(a)(2)]

On or about July 19, 2010, in the Western District of Texas, the Defendant,

ROXANN MARIE RODRIGUEZ

in connection with the acquisition of a firearm, a Century Arms WASR 10-63 7.62 x 39 rifle, serial number 1965MN4904, from Nagel Gun Shop, Inc., a federally licensed firearms dealer, knowingly made a false and fictitious oral or written statement, which statement was intended and likely to deceive the dealer as to a fact material to the lawfulness of such sale of the said firearm to the Defendant, in that the Defendant represented that she was the actual buyer of the firearm, when in fact she was not the actual buyer of the firearm; in violation of Title 18, United States Code, Sections 922(a)(6) and 924(a)(2).

COUNT TWO

[18 U.S.C. §§ 922(a)(6) & 924(a)(2)]

On or about August 8, 2010, in the Western District of Texas, the Defendant,



in connection with the acquisition of a firearm, a Century Arms/TULA SKS 7.62 x 93 rifle, serial number 21000719AP, from Spreadfire, a federally licensed firearms dealer, knowingly made a false and fictitious oral or written statement, which statement was intended and likely to deceive the dealer

as to a fact material to the lawfulness of such sale of the said firearm to the Defendant, in that the Defendant represented that she was the actual buyer of the firearm, when in fact she was not the actual buyer of the firearm; in violation of Title 18, United States Code, Sections 922(a)(6) and 924(a)(2).
