

SAFETY RECALL NOTICE REGARDING CZ ALL AMERICAN SINGLE TRAP SHOTGUNS

CZ-USA has recently learned of a safety issue with all CZ All American Single Trap shotguns. CZ-USA is voluntarily initiating a recall of these shotguns to protect the safety of its customers because of the potential that they could unintentionally discharge if the trigger is pulled with the safety engaged and/or if they are dropped, even with the safety engaged.

To prevent the possibility of death or serious personal injury, you should immediately stop using your CZ All American Single Trap shotgun and not load or fire it until it has been returned to CZ-USA to be inspected and upgraded.

CZ-USA will upgrade the CZ All American Single Trap shotguns in the order in which it received them for inspection and upgrade pursuant to this recall.

A. CZ-USA is voluntarily initiating a recall to protect the safety of its customers and is committed to the highest standards of quality and customer satisfaction. CZ-USA recently learned of a potential safety issue with the CZ All American Single Trap shotguns. It was determined that there is the potential that the shotguns could unintentionally discharge if the trigger is pulled with the safety engaged and/or if they are dropped, even with the safety engaged. Such an unintentional discharge could potentially result in death or serious injury.
